Christmastime at Fine Line

Show and Sale • November 30 - December 8, 2012

Fine Line Creative Arts Center is holding its 25th annual juried Christmastime at Fine Line Members Show and Sale this November 30 - December 8, 2012. We invite you to apply and sell your handmade, one-of-a-kind fine arts and crafts. Works will be displayed throughout the Kavanagh Gallery and building. No individual booth spaces are available. The entire show is set-up in a gallery shop format. Your work will be inventoried, so you need not be present to conduct sales.

Returning Artists

You are a returning artist if you were in last year's show or in the 2012 Uncommon Threads Boutique.

- Complete the Application Form including your media and description of work to be shown.
- Submit a \$20 Application fee along with your application. Make check payable to Fine Line.
- If you are showing a new type of work than what you showed last year you must submit images and follow the "New Artist" directives.

New Artists

- Complete and submit the Application Form with slides, photos or .jpg images on a CD of the work you would like to show. Make check payable to Fine Line.
- Submit a \$20 jury fee along with your application and images of work to be juried.

All Artists

You must be a current member of Fine Line

as of November 28, 2012 to show and sell your work at the Christmastime at Fine Line Show and Sale. If you are not sure about your membership expiration date, email info@fineline.org with your request, or call Fine Line (630)584-9443. Office/shop hours are Monday – Saturday from 10am – 5pm. Membership Applications can be found on our website at www.fineline.org. You can join online.

1). All artists accepted into the show are required to:

- Pay a \$20 Application Fee (submitted with application.) **Deadline Monday, October 8, 2012.**
- Volunteer in the Gallery for one morning, afternoon or evening shift between Saturday, December 1 through Saturday, December 8.
- Use the price tags provided and properly label items with your artist code.
- Use the consignment form provided. If you would like an electronic format, please contact Amanda via e-mail at amanda@fineline.org.

2). All items placed in the show must be for sale and reflect a 30% donation to Fine Line. All unsold items must remain in the show until it closes at 5pm on Saturday, December 8.

3). All items must be delivered to the Kavanagh Gallery on Wednesday, November 28 between 10am and 8pm. Do not simply drop off your work and leave. Check-in will be located in the Kavanagh Gallery and a Fine Line staff person must check your inventory with you. Additional items will not be accepted after Thursday, December 1st. If we need more items, we'll contact you.

4). All unsold items must be picked up on Wednesday, December 12, 2012, between 10am and 8pm. If you cannot make this date, you will need to make arrangements for someone to do this for you. Personnel will not be available to check you out, nor will we be responsible for your items, after Wednesday, December 12, 2012. Checks for merchandise sold during the show will be mailed within one week of inventory pickup to the address provided on your application form.

5). All artists will receive ten promotional postcards. If you would like more, please pick them up at Fine Line.

ATTENTION: A FINAL NOTE! Although we are always looking for that spark of freshness, originality, creativity – whatever you call that quality that really brings a piece to life, we will be looking to see that your overall finishing techniques and presentation convey a refinement and quality that adds to its overall design. All work must be original and made by the artist within the last few years. Commercial items will not be accepted. In the final analysis, when we are setting up the show, Fine Line and the Christmastime Committee reserve the right to refuse exhibition of work not consistent with submitted images or the guidelines of the show. We at Fine Line, as well as our clientele, expect the best in our craftsmanship.

I agree to abide by the specifications described in this application. If I am a New Artist, I've enclosed at least four (4) and up to five (5) images showing the quality of the work with which I wish to submit and a SASE (self addressed stamped envelope) with postage of at least \$1.51 to guarantee that my images will be judged by competent jurors and returned to me. I understand that all work must be original and creative with no copies or kits. I understand that I may choose to present 4 to 5 slides, photos or .jpg images on a cd of my work and that the Christmastime Committee will make final selections of the work to be displayed in the show. If I am accepted into the show, I agree to submit my work on time, pick it up on time, pay the \$20 JURY/APPLICATION FEE, and VOLUNTEER time in the Gallery to help with the sales of merchandise.

1). For Slides: Use 35mm slides only. All slides must be sent in a slide sleeve in this format: In the upper right-hand corner (as you would hold it in your hand to view it) put your name and a number (1 - 5) to correspond with the written description of the work shown in that slide. **For Photos or .JPG images on a CD:** Make sure to indicate the number and title of your photos or images to correspond/match your descriptions below. Do not put your name to any numbered image.

2). Print the following information in the space provided below: Title, Technique/Description of Work, Size and Sale Price. The description will be referred to at the request of the jurors. You must jury at least four (4) items and submit a detailed image of one of the four:
